



COVID-19 Campus Exposure Procedure

Possible Exposure – Dorm Students

1. If you believe you have had contact with a possible individual who has tested positive for COVID-19, you are instructed to contact Student Success Advisor/Residential Advisor Simon Aina.
2. Immediately self-isolate in your dorm room following exposure for 10 days. No-contact delivery for food and other items will be available to the student.

All Supervisors

1. All supervisors/employees who have been contacted about a possible or confirmed exposure, or has tested positive for COVID-19, follow these procedures:
 - a. **Contact Dean of Administration, Heather Dingman immediately.**

 - b. Leave campus premises and self-isolate at home for 10 days.
 - c. KC Janitorial Cleaners will then be notified to sanitize affected areas.
 - d. M&O will be contacted so that the area(s) can be marked off from public access.

Classroom Exposure

1. If there is an exposure in a classroom, all students in the classroom must be notified **immediately**.
2. In-person class will not resume for 10 days after exposure and students should not return to campus before then.
3. Classroom will be sanitized immediately and will not be used for 10 days.

President's Office

4. President Wilhelm and/or her Executive Assistant will notify Ilisagvik faculty and staff of the exposure on campus via email. Updates will be provided as necessary.

Frequently Asked Questions

What does quarantine and isolation mean?

Quarantine status means the individual is a close contact of a positive case and has been exposed to the COVID-19 virus. This person will need to remain in quarantine from 10 days after their last contact with the positive case. However, if the individual is fully vaccinated with the COVID-19 vaccine, and they are not experiencing any symptoms, quarantining is not required. This follows CDC guidelines.

Isolation status means having tested positive for the COVID virus. This person will need to remain in isolation for a minimum of 10 days, with the last 48 hours of the isolation period being without any symptoms and without taking any medications to mask their symptoms.

What happens when someone tests positive in the dorms?

Follow COVID-19 Dorm Procedures which is attached to this document. The first step is to contact the Residential Advisor immediately followed by the positive-tested individual to isolate and subsequently quarantine in their dorm room. Contact tracing will commence with Arctic Slope Native Association.

Who counts as a close contact?

- If you were within 6 feet to someone who has tested positive for COVID-19 for 15 minutes or more, you are considered a close contact.
- You had direct physical contact with someone with COVID-19 (hug or kiss).
- You shared eating utensils with someone with COVID-19.
- An individual with COVID-19 coughed or sneezed on you, or got respiratory droplets on you.

Will the Fall 2021 semester be in-person?

Yes. Iñisaġvik College will transition to Phase 4, “Fully Operational” by the summer 2021 semester with options for in-person classes and distance delivery. All classrooms will have the option to use shields to separate students and masks will be required.
